

# Annual Drinking Water Quality Report for 2024

## INTRODUCTION

To comply with State regulations, The Town of Trenton will be annually issuing a report describing the quality of your drinking water. The purpose of this report is to raise your understanding of drinking water and awareness of the need to protect our drinking water sources. Last year, your tap water met all State drinking water health standards. We are proud to report that our system did not violate a maximum contaminant level or any other water quality standard. This report provides an overview of last year's water quality. Included are details about where your water comes from, what it contains, and how it compares to State standards.

## WHERE DOES OUR WATER COME FROM?

In general, the sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activities. Contaminants that may be present in source water include microbial contaminants; inorganic contaminants; pesticides and herbicides; organic chemical contaminants; and radioactive contaminants. In order to ensure that tap water is safe to drink, the State and the EPA prescribe regulations that limit the amount of certain contaminants in water provided by public water systems. The State Health Department's and the FDA's regulations establish limits for contaminants in bottled water which must provide the same protection for public health.

Our water system serves approximately 171 service connections providing water to 400 residents. Our water source is a system of springs located outside the village on village owned property. The water is currently filtered and disinfected with chlorine prior to entering the distribution system.

## SOURCE WATER ASSESSMENT INFORMATION

A Source Water Assessment has been completed for the BARNEVELD WATER DISTRICT Water System. Possible and actual threats to drinking water source(s) were evaluated. The state source water assessment includes a susceptibility rating based on the risk posed by each potential source of contamination and how easily contaminants can move through the subsurface to the source(s). The susceptibility rating is an estimate of the potential for contamination of the source water, it does not mean that the water delivered to consumers is, or will become contaminated. The Source Water Assessment Program (SWAP) is designed to compile, organize and evaluate information to make better decisions regarding protecting sources of public drinking water. A copy of the assessment, including a map of the assessment area, can be obtained by contacting us, as noted above.

The land uses around the BARNEVELD WD Water System sources were rated for their potential to cause contamination to the sources. The Barneveld sources were considered at a low risk for most contaminants related to land use and medium susceptibility to protozoa and Disinfection By-



Product Precursors. The sources did receive a medium risk rating for enteric viruses. When combined with a low risk of contamination from discrete sources and a high natural sensitivity based on soils, contaminant history, surficial geology, aquifer information and bedrock geology, this created a medium high susceptibility for the source to contamination. The source water assessments provide resource managers with additional information for protecting source waters into the future.

Based upon the SWAP Report determinations, good judgment should be used and caution should be exercised when determining placement of certain materials, actions and facilities, including septic systems, high-risk businesses or chemical storage near the source(s). We work hard to ensure that the source of water for our system is protected from contamination.

## GROUNDWATER UNDER THE DIRECT INFLUENCE OF SURFACE WATER (GWUDI) INFORMATION

From 2003-2005, the Oneida County Health Department conducted a study of our water system to determine if our source was under the direct influence of surface water. Based upon the data collected (e.g. temperature, conductivity, and precipitation), geology, construction methods, and soils, the OCHD determined that the water source for the water system demonstrates characteristics of a groundwater source that is under the direct influence of surface water (GWUDI). Therefore, we were required to take action to meet the water treatment standards established by the USEPA and New York State.

Beginning in April 2014, we began sampling our RAW / UNTREATED water from all 4 sources for E.coli bacteria. This sampling occurred every other week for a year. As a result of the sampling, and the upgrades to our water sources, our water system was declared true groundwater. Therefore, we are no longer required to filter our water according to the standards for GWUDI sources. However, we will continue to provide filtration as a precaution.

## ARE THERE CONTAMINANTS IN OUR DRINKING WATER?

As the State regulations require, we routinely test your drinking water for numerous contaminants. These contaminants include total coliform, inorganic compounds, nitrate, nitrite, lead and copper,

radioactive contaminants, disinfection byproducts, volatile organic compounds, and synthetic organic compounds. The table presented below depicts which compounds were detected in your drinking water. The State allows us to test for some contaminants less than once per year because the concentrations of these contaminants do not change frequently. Some of our data, though representative, may be more than one year old.

It should be noted that all drinking water, including bottled drinking water, might be reasonably expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. **Notes:**

- 1 - Turbidity is a measure of the cloudiness of the water. We test it because it is a good indicator of the effectiveness of our filtration system. Our highest single entry point (pre-distribution system) turbidity measured at a level of 0.22 NTU. During 2022, 100% of samples collected for filtration compliance were below the 1NTU treatment technique standard. State regulations require that turbidity must always be below 5 NTU. 100% of turbidity samples collected in 2022 were below 5NTU.
- 2 - The level presented represents the 90<sup>th</sup> percentile of the five (5) sites tested. A percentile is a value on a scale of 100 that indicates the percent of a distribution that is equal to or below it. The 90<sup>th</sup> percentile is equal to or greater than 90% of the copper values detected at your water system. In this case, five (5) samples were collected at your water system and the 90<sup>th</sup> percentile value was the average of the two highest values. The action level for copper was not exceeded at any of the sites tested. Copper in water supplies is a health concern for person with Wilson's Disease (a rare genetic disease).
- 3 - The level presented represents the 90<sup>th</sup> percentile of the five (5) samples collected. The action level for lead was not exceeded at any of the sites tested.
- 4 - The values presented represent the average and range of the levels reported on the microbiological sampling reports.
- 5 - Value presented represents the Maximum Residual Disinfectant Level (MRDL) which is a level of disinfectant added for water treatment that may not be exceeded at the consumer's tap without an unacceptable possibility of adverse health effects. MRDLs are currently not regulated but in the future they will be enforceable in the same manner as MCLs.

<b>ACTION LEVEL</b>	<b>AL</b>	The concentration of a contaminant that, if exceeded, triggers treatment or other requirements that a water system must follow.
<b>MAXIMUM CONTAMINANT LEVEL</b>	<b>MCL</b>	The highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible.
<b>MAXIMUM CONTAMINANT LEVEL GOAL</b>	<b>MCLG</b>	The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.

### **WHAT DOES THIS INFORMATION MEAN?**

During 2023 Barneveld WD was required to collect samples for PFOA, PFOS and 1,4 dioxane. In December 2023 we collected the samples as required but have not received the results from our contract laboratory. We are continuing to try and resolve the issue with the laboratory. We have learned through our testing that some contaminants have been detected; however, all of these contaminants were detected below New York State requirements.

### **IS OUR WATER SYSTEM MEETING OTHER RULES THAT GOVERN OPERATIONS?**

Last year, our system complied with the applicable New York State drinking water operating, monitoring and reporting requirements.

### **CLOSING**

Please note that as a result of the dissolution of the Village of Barneveld, effective January 1, 2018, the water system is now the responsibility of the Town of Trenton. Thank you for allowing us to continue to provide your family with quality drinking water this year. In order to maintain a safe and dependable water supply we sometimes need to make improvements that will benefit all of our customers. The costs of these improvements may be reflected in the rate structure. Rate adjustments may be necessary in order to address these improvements. We ask that all our customers help us protect our water sources, which are the heart of our community. Please call our office if you have questions.

### **LEAD INFORMATION**

Lead can cause serious health effects in people of all ages, especially pregnant people, infants (both formula-fed and breastfed), and young children. Lead in drinking water is primarily from materials and parts used in service lines and in home plumbing. The Barneveld Water District is responsible for providing high quality drinking water and removing lead pipes but cannot control the variety of materials used in the plumbing in your home. Because lead levels may vary over time, lead exposure is possible even when your tap sampling results do not detect lead at one point in time. You can help protect yourself and your family by identifying and removing lead materials within your home plumbing and taking steps to reduce your family's risk. Using a filter, certified by an American National Standards Institute accredited certifier to reduce lead, is effective in reducing lead exposures. Follow the instructions provided with the filter to ensure the filter is used properly. Use only cold water for drinking, cooking, and making baby formula. Boiling water does not remove lead from water. Before using tap water for drinking, cooking, or making baby formula, flush your pipes for several minutes. You can do this by running your tap, taking a shower, doing laundry or a load of dishes. If you have a lead service line or galvanized requiring replacement service line, you may need to flush your pipes for a longer period. ### **WHY SAVE WATER AND HOW TO AVOID WASTING IT?**

Although our system has an adequate amount of water to meet present and future demands, there are a number of reasons why it is important to conserve water:

- Saving water saves energy and some of the costs associated with both of these necessities of life;
- Saving water reduces the cost of energy required to pump water and the need to construct costly new wells, pumping systems and water towers; and
- Saving water lessens the strain on the water system during a dry spell or drought, helping to avoid severe water use restrictions so that essential fire-fighting needs are met.

You can play a role in conserving water by becoming conscious of the amount of water your household is using, and by looking for ways to use less whenever you can. It is not hard to conserve water. Conservation tips include:

- Automatic dishwashers use 15 gallons for every cycle, regardless of how many dishes are loaded. So get a run for your money and load it to capacity.
- Turn off the tap when brushing your teeth.
- Check every faucet for leaks. Just a slow drip can waste 15 to 20 gallons a day. Fix it up and you can save almost 6,000 gallons per year.
- Check toilets for leaks by putting a few drops of food coloring in the tank - watch for a few minutes to see if the color shows up in the bowl. It is not uncommon to lose up to 100 gallons a day from one of these otherwise invisible toilet leaks. Fix it and you save more than 30,000 gallons a year.
- Use Heat Tape to protect your pipes from freezing. This will save water AND protect septic systems from overuse.
- Use your water meter to detect hidden leaks. Simply turn off all taps and water using appliances, then check the meter after 15 minutes, if it moved, you have a leak.

### **DO I NEED TO TAKE SPECIAL PRECAUTIONS?**

Some people may be more vulnerable to disease causing microorganisms or pathogens in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. These people should seek advice from their health care provider about their drinking water. EPA/CDC guidelines on appropriate means to lessen the risk of infection by Cryptosporidium, Giardia and other microbial pathogens are available from the Safe Drinking Water Hotline (800-426-4791).

### **Lead Service Line Inventory**

A Lead Service Line (LSL) is defined as any portion of pipe that is made of lead which connects the water main to the building inlet. An LSL may be owned by the water system, owned by the property owner, or both. The inventory includes both potable and nonpotable SLs within a system.
